# 携帯電話の比吸収率 (SAR) について / Specific Absorption Rate (SAR) of Mobile Phones

## 1. SO-01M @ SAR / About SAR of SO-01M

#### (日本語)

この機種【SO-01M】の携帯電話機は、国が定めた電波の人体吸収に関する技術基準および電波防護の国際ガイドラインに適合しています。

この携帯電話機は、国が定めた電波の人体吸収に関する技術基準(※1)ならびに、これと同等な国際ガイドラインが推 奨する電波防護の許容値を遵守するよう設計されています。この国際ガイドラインは世界保健機関(WHO)と協力関係に ある国際非電離放射線防護委員会(ICNIRP)が定めたものであり、その許容値は使用者の年齢や健康状況に関係なく十分 な安全率を含んでいます。

国の技術基準および国際ガイドラインは電波防護の許容値を人体に吸収される電波の平均エネルギー量を表す比吸収率 (SAR: Specific Absorption Rate) で定めており、携帯電話機に対する SAR の許容値は 2.0W/kg です。この携帯電話機の頭部における SAR の最大値は 0.88 W/kg (※2)、身体に装着した場合の SAR の最大値は 0.66 W/kg (※3) です。個々の製品によって SAR に多少の差異が生じることもありますが、いずれも許容値を満足しています。

携帯電話機は、携帯電話基地局との通信に必要な最低限の送信電力になるよう設計されているため、実際に通話等を行っている状態では、通常 SAR はより小さい値となります。一般的には、基地局からの距離が近いほど、携帯電話機の出力は小さくなります。

この携帯電話機は、頭部以外の位置でも使用可能です。キャリングケース等のアクセサリをご使用するなどして、身体から 1.5 センチ以上離し、かつその間に金属(部分)が含まれないようにしてください。このことにより、本携帯電話機が国の技術基準および電波防護の国際ガイドラインに適合していることを確認しています。

世界保健機関は、『携帯電話が潜在的な健康リスクをもたらすかどうかを評価するために、これまで 20 年以上にわたって多数の研究が行われてきました。今日まで、携帯電話使用によって生じるとされる、いかなる健康影響も確立されていません。』と表明しています。

#### (In English)

This model [SO-01M] mobile phone complies with Japanese technical regulations and international guidelines regarding exposure to radio waves.

This mobile phone was designed in observance of Japanese technical regulations regarding exposure to radio waves (\*1) and limits to exposure to radio waves recommended by a set of equivalent international guidelines. This set of international guidelines was set out by the International Commission on Non-Ionizing Radiation Protection (ICNIRP), which is in collaboration with the World Health Organization (WHO), and the permissible limits include a substantial safety margin designed to assure the safety of all persons, regardless of age and health condition.

The technical regulations and international guidelines set out limits for radio waves as the Specific Absorption Rate, or SAR, which is the value of absorbed energy in any 10 grams of tissue over a 6-minute period. The SAR limit for mobile phones is 2.0 W/kg. The highest SAR value for this mobile phone when tested for use near the head is **0.88 W/kg** (\*2) and when worn on the body is **0.66 W/kg** (\*3). There may be slight differences between the SAR levels for each product, but they all satisfy the limit.

The actual SAR of this mobile phone while operating can be well below that indicated above. This is due to automatic changes to the power level of the device to ensure it only uses the minimum required to reach the network. Therefore in general, the closer you are to a base station, the lower the power output of the device.

This mobile phone can be used in positions other than against your head. Please keep the mobile phone farther than 1.5 cm away from your body by using such as a carrying case or a wearable accessory without including any metals. This mobile phone satisfies the technical regulations and international guidelines.

The World Health Organization has stated that "a large number of studies have been performed over the last two decades to assess whether mobile phones pose a potential health risk. To date, no adverse health effects have been established as being caused by mobile phone use."

# Radio Wave Exposure and Specific Absorption Rate (SAR) Information

THIS PHONE MODEL HAS BEEN CERTIFIED IN COMPLIANCE WITH THE GOVERNMENT'S REQUIREMENTS FOR EXPOSURE TO RADIO WAVES.

The SO-01M Series mobile phones have been designed to comply with applicable safety requirements for exposure to radio waves. Your wireless phone is a radio transmitter and receiver.

It is designed to not exceed the limits\* of exposure to radio frequency (RF) energy set by governmental authorities. These limits establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by international scientific organizations through periodic and thorough evaluation of scientific studies.

The standards include a safety margin designed to assure the safety of all individuals, regardless of age and health.

The radio wave exposure guidelines employ a unit of measurement known as the Specific Absorption Rate (SAR). Tests for SAR are conducted using standardized methods with the phone transmitting at its highest certified power level in all used frequency bands.

While there may be differences between the SAR levels of various phone models, they are all designed to meet the relevant guidelines for exposure to radio waves.

The highest SAR value as reported to the authorities for this phone model when tested for use by the ear is **0.42 W/kg\***, when worn on the body is **0.34 W/kg\*** and when WiFi hotspot mode is **0.54 W/kg**. For body-worn operation, this phone has been tested and meets the FCC RF exposure guidelines. Please use an accessory designated for this product or an accessory which contains no metal and which positions the handset a minimum of 15 mm from the body.

For devices which include "WiFi hotspot" functionality, SAR measurements for the device operating in WiFi hotspot mode were taken using a separation distance of 10 mm.

Use of third-party accessories may result in different SAR levels than those reported.

\*\* Before a phone model is available for sale to the public in the US, it must be tested and certified by the Federal Communications Commission (FCC) that it does not exceed the limit established by the government-adopted requirement for safe exposure\*. The tests are performed in positions and locations (i.e., by the ear and worn on the body) as required by the FCC for each model. The FCC has granted an Equipment Authorization for this phone model with all reported SAR levels evaluated as in compliance with the FCC RF exposure guidelines. While there may be differences between the SAR levels of various phones, all mobile phones granted an FCC equipment authorization meet the government requirement for safe exposure. - \* In the United States, the SAR limit for mobile phones used by the public is 1.6 watts/kilogram (W/kg) averaged over one gram of tissue. The standard incorporates a margin of safety to give additional protection for the public and to account for any variations in measurements.

### 3. About SAR of SO-01M for EU RF exposure requirements

# Radio Wave Exposure and Specific Absorption Rate (SAR) Information

This mobile phone model SO-01M has been designed to comply with applicable safety requirements for exposure to radio waves. These requirements are based on scientific guidelines that include safety margins designed to assure the safety of all persons, regardless of age and health.

The radio wave exposure guidelines employ a unit of measurement known as the Specific Absorption Rate, or SAR.

Tests for SAR are conducted using standardized methods with the phone transmitting at its highest certified power level in all used frequency bands.

While there may be differences between the SAR levels of various phone models, they are all designed to meet the relevant guidelines for exposure to radio waves.

SAR data information for residents in countries that have adopted the SAR limit recommended by the International Commission on Non-Ionizing Radiation Protection (ICNIRP), which is 2 W/kg averaged over ten (10) gram of tissue (for example European Union, Japan, Brazil and New Zealand): For body worn operation, this phone has been tested and meets RF exposure guidelines when used with an accessory that contains no metal and that positions the handset a minimum of 5 mm from the body. Use of other accessories may not ensure compliance with RF exposure guidelines.

The highest SAR value for this model phone when tested by Sony for use at the ear is **0.38 W/kg** (10g). In the case where the phone is worn on the body, the highest tested SAR value is **0.82 W/kg** (10g).
